Membership Type

***Family** – includes primary member, spouse and all dependent unmarried children under the age of twenty-one (21) or twenty-three (23) if a full time student in an institution of college equivalency.

****Individual** - includes the individual member only. The spouse and all dependent unmarried children under the age of twenty-one (21) or twenty-three (23) if a full time student in an institution of college equivalency do not have member privileges. They may use the club facilities as a guest of the member in conjunction with the guest policies.

*****Corporate** – employees of a corporation may join the Club at discounted rates. After a primary member (authorized agent of the corporation) joins as a Full or Social member, up to 5 employees of the corporation may “buy in” by means of the reduced initiation fee under the Corporation’s membership. Employees will not be required to buy/own shares. Additional information is noted in the Rules and Regulations.

******29 and Under & 30 to 39** – Membership is for families 29 and Under & 30 to 39. Upon reaching their 30th birthday they will move to the 30 to 39 category and upon reaching their 40th birthday they will move into the next category of membership that fits their situation. (The age of the oldest person is the one used for membership category purposes.)

*******Legacy 29 and Under & 30 to 39** – Available to children of current members in good standing that are over 21 years of age. Upon reaching their 30th birthday they will move to the Legacy 30 to 39 category and upon reaching their 40th birthday they will move into the next category of membership that fits their situation. Once a legacy marries or lives with a significant other, the oldest age of the two will be used for membership category purposes.

******* Out of Town Membership**- Available to those living 40+ miles away from the club.

Transitions to different membership types are welcomed however there are restrictions that apply to changes from a Full to Social, Social to Clubhouse or Full to Clubhouse. There are no restrictions to changes to memberships offering more access to the Club than current. Please inquire for more details.

Food and Beverage Minimum – The culinary offerings at the club abound with variety, location and quality. The menus are designed with the member in mind. Local products are used where possible and the menus are changed seasonally. Additionally our team is more than willing to accommodate any taste or dietary preferences or needs. The minimum members are asked to purchase is \$110 per 3 months. The three months are predicated on the alphabetic listing of the last name. Food and Beverage spend that contributes to the minimum excludes alcohol.
